Many business faculty work with librarians to provide one shot instruction or information literacy instruction to their students but they may not see the value in continued engagement with librarians. Trends in recent years have created new roles of librarians that not only provide traditional services but expand to create opportunities to unite students and faculty in a way that flexible sustainable workforce.

From this session, the author hopes participants will meet the following objectives:

- Identify new ways to engage University librarians
- Find experiential learning opportunities for students and faculty that will aid in retention
- Identify new ways to expand roles of librarians and faculty for teaching and learning

The ARL (association of research libraries) has conducted a study which identifies that libraries and the roles that libraries play in teaching and learning are evolving. New roles in libraries are being created to build better relationships and collaboration opportunities to meet and exceed the student learning outcomes.

This session will allow management educators to see collaboration opportunities in a new way to not only build the experiential learning opportunity for their students but to build communities of practice for their career advancement.
