Proposed Title:
Teaching Students about the Working Poor
Abstract:
The concept of the working poor is largely overlooked in organizational behavior research while the ranks of the working poor are increasing. Limited research that does exist questions basic assumptions we have about motivation, perceptions, and behavior among the working poor. What should we teach our students about the working poor in light of this emerging research? This session builds on a session at OBTC 2015 and offers suggestions to management educators who want to introduce future leaders and managers to this emerging topic through use of the SNAP Challenge tailored to OB concepts.

5) Teaching Implications:

This session has significant teaching implications. By all accounts, the population of those considered "working poor" is increasing. The crossroad of low-wage work and poverty affects work-related behaviors and outcomes. Traditional agentic behaviors at work, upon which most management educators build their pedagogy, seldom apply to the working poor. This topic is essentially ignored in management education (Leana & Meuris,2015; Leana, Mittral & Stiehl, 2012). This session will they can draw to introduce students to new and emerging thought with respect to how they might plan, organize, lead, and control work tasks that are assigned to the working poor.

The learning objectives of this session are as follows:

- 1. Heighten awareness of the influence of poverty on work attitudes and behaviors
- 2. Invite reflection regarding the theories from which we draw when we develop teaching and learning activities in organizational behavior
- 3. Introduce management practices and supervisory skills associated with the working poor that educators can teach their students
- Relate experiences with altering the SNAP challenge (Dr. Kim Gowar's session at OBTC 2015) to introduce basic concepts of the working poor to students in an Organizational Behavior class

6) Session Description and Plan:

We need to provide students with new information so they can succeed as future leaders and managers of their employees who may be among the ranks of the working poor
- (25 minutes) Introduce session participants to student experiences associated with the altered OB-specific SNAP Challenge experience developed as a result of OBTC 2015
- 5. (10 minutes) Debrief/questions/comments

This session will help management educators encourage students to "think beyond" the textbook to broaden their understanding of what it means to lead and manage those who are working (often full-time) yet still living in poverty: How do we lead and manage those individuals so that we are not providing a disservice to them?
