Title: Using a Web-based Platform to Administer Simulations and Role-Plays So You Can Focus on Teaching

Abstract:

Experiential exercises can be difficult and time-consuming to administer, and the student experience can be reduced when they fail to run smoothly.

The iDecisionGames platform automates the tedious tasks involved in experiential exercises (face-to-face or online). Professors use iDecisionGames to run simulations effortlessly and provide students with instantaneous insights. Students use iDecisionGames to receive their role and team assignments, review individual and class results, and answer pre- and post-survey questions.

Join us for an interactive session to try an exercise on the iDecisionGames platform and discuss how iDecisionGames could be used in your classroom. Bring a laptop!

Management educators want to use experiential exercises in their courses, but they can be complicated and time-consuming. Instead of focusing on learning objectives, educators are often hindered by tedious activities, such assigning groups or collecting and analyzing data. To be most effective, students must prepare for the exercises and have clear understanding of the results. When prepared, students can engage more deeply with the material and become a more realistic partner or teammate within the exercise. Armed with instantaneous data analysis, debrief discussions and reflections can be rich and inclusive.

iDecisionGames lets instructors focus on teaching and automates the administrative tasks involved in running simulations. With iDecisionGames, running exercises becomes effortless. Educators can use the platform to:

- Distribute role-specific instructions directly to students' devices
- Form groups, account for absences, and ensure that students have unique partners for each exercise (if desired)
- Get real-time insight into students' answers as they complete the exercise
- Aggregate results automatically across all students
- Automatically graph results and send customized reports to students

The iDecisionGames platform (<u>www.idecisiongames.com</u>) can be used in any course that utilizes role-play exercises – both in-class and online. Professors have found the platform to be helpful in Negotiations, Organizational Behavior, and Leadership courses. Instructors can use their own cases and materials or choose from more than 300 cases in the library.

Of course, teaching with technology can be a difficult step for some educations, and there are concerns about quality, support, and cost. We acknowledge the potential challenges of leveraging this technology in the classroom.

During this session, participants will:

- Gain a basic understanding of the features of the iDecisionGames platform
- Experience participating in an exercise run through the iDecisionGames platform
- Learn how to customize iDecisionGames for their unique situation
- Discuss the opportunities and challenges involved in moving to a digital platform
